

REGULATION:



Gates open at 08:00 a.m., accommodation on the spot at 10:00 if the spot booked is already occupied, otherwise it can be anticipated upon permission of the accommodation management.

The payment refers to the single spot.

SINGLE SPOTS: 3 rods per station (spots: 1 / 6 / 7 / 9)

DOUBLE SPOTS: 6 rods per station (spots: 1 / 2 / 3 / 4 / 5 / 6 / 8 / 9 / 10 / 11)

Access to the lake and fishing is allowed only to ARCI PESCA card holders.









The fishing permit and any membership are issued at the BAR against fee payment exclusively for catch & release fishing.

Once at the pitch, the car must be parked close to the owner, without possibility of use for the whole duration of the fishing permit except for emergency cases.





The pitches will always be provided clean and checked at the end of the session, we assure our commitment to maintain a healthy and clean environment and we trust in your cooperation.

Violators of the following rules will be turned away and no longer readmitted to the park!













OBLIGATORY:

-  **ARCI PESCA card.**
-  **Hooks with micro barb, size from N° 1 to N° 4.**
-  **Nylon in 0.40 or larger spools.**
-  **Cradle raised from the ground with high sides.**
-  **Disinfectant suitable for the possible care of the fish.**
-  **In having to go to the toilets or at the bar, if the only fisherman, obligation to recover the lines out of the water.**
-  **Leave the pitch by 10.00 AM on the day of the end of the permit.**
-  **The use of the toilets equipped with toilets and showers at the entrance next to the bar.**

ALLOWED:

-  **The use of the DEEPER.**
-  **Baiting with SPOMB from 10.00 AM to 11.00 AM and from 17.00 PM to 18.00 PM.**
-  **Baiting with BOILES, PELLETS and CORN FLAKES.**
-  **Bags exclusively floating the bare essentials (unhooking / transport in cradle / release).**
-  **Barbecue raised off the ground.**
-  **N ° 2 accompanying persons per pitch.**
-  **N ° 2 visitors per pitch from 10.00 AM to 18.00 PM a possible stay of visitors must be communicated and agreed with the management at a cost of € 5.00 per person.**

FORBIDDEN:

-  **Hooks no smaller than N ° 4 and barbless.**
-  **Nylon in spool of less than 0.40.**
-  **The use of small boats and any other remote-controlled and non-remote-controlled craft.**
-  **The use of braid on the reel, shock leader and lead core.**
-  **Baiting with live bait, blood and derivatives, corn, hemp, all types of legumes, flour and method.**
-  **Floor type mattress.**
-  **ZIG RIG fishing or long rigs.**
-  **Cut down trees, branches or reeds.**
-  **Throwing butts, cigarettes and various garbage on the ground.**
-  **Fires ashore throughout the lake.**
-  **Entrance to large dogs.**
-  **Use of the car for travel within the park.**
